Health Information Technology Extension Program

The American Recovery and Reinvestment Act of 2009 that President Barack Obama signed this month includes the Health Information Technology (HIT) Extension Program and there may be grants and loans available for health IT adoption.

Title XIII of the Act focuses on HIT and quality, and \$19 billion in grants and loans has been set aside for infrastructure and incentive payments under Medicare and Medicaid for providers who adopt certified EHR technology. The grants and loans include \$17 billion slated for incentives, with \$2 billion allotted to jump-start health IT adoption.
